# Opening of the meeting – 10:00am

- There have been a lot of changes and some frustration this year and hopes a lot of our questions will be answered later in the meeting.

## **Association Manager Report – Anne-Marie Cole**

Anne-Marie gave the Association Manager's report Highlights:

- She referred to the Stats for Ontario for the counts of bowlers in Ontario. This includes the number of delegates each association is allowed at the Annual Meeting
- She pointed out the Association High Average Report for 2016-2017 and how some of the Youth averages were spectacular.
- Charlotte and Anne-Marie went over the financial reports that were in the package. The
  first report was for the previous year as there was not a complete financial report that
  year. Charlotte spoke to the first report. Della Trude motioned to accept the first
  financial report and Wayne Dubs seconded the motion. Motion carried
- Anne-Marie went over the second report, which is for the current year. The final balance is estimated to be \$13,136.04. A motion to accept by Wayne Dubs, seconded by Gary Rochon, carried.

# **Committee Reports**

#### Awards

- Karen gave a report on what the awards were and how bowlers are eligible for them. She mentioned that the folding tote bag and cell phone/keychain case were eligible to all adult OTBA members. These are once in a lifetime awards. Association Managers need to submit the information to the OTBA Association Manager. There was a brief discussion as to whether a Youth bowler bowling in an adult league would be eligible for the award. They are eligible.

#### Hall of Fame

- Della reported that the committee would not be inducting anyone into the Hall of Fame this year. Pierre Gratton, CDTBA asked how they asked each association for nominations as he has not received any information on it. It was mentioned that all the forms are on the OTBA Website.

- Scholarship
  - John McLean went over the scholarship report. He mentioned that the surplus is \$60,000. This number is dropping, as we want it to. We have a total in \$251,552 in the fund, and the liabilities total \$189,407. There is a list on the OTBA website of all youth that have scholarships coming to them.

- Tournaments Youth
  - Jayne Picott gave an update on the Youth tournaments, including the Ivan Nelson, Family Twosome, CYCs and Youth Provincial Tournaments. She noted that the fee for the Family Twosome has increased from \$26 to \$32 and the tournament will only be held on one day instead of being held over two days. The Singles tournament is also only being held on one day instead of two due to lane availability.

#### • Tournaments - Senior

- Charlotte gave an update on the Seniors tournament. There were 229 entries and 6 bowlers will be going the Tournament in Reno.

#### Tournaments – Adult

- Karen gave a report of the 2017 Adult Tournament. The tournament went well but the final results and financials were delayed due to the ten-pin rule being in effect.

- Wayne gave a report of the 2018 Adult Tournament. The tournament went well but the entries were down a bit from the last time they hosted the tournament. He said the checks would be going out in the next week or so. The official results are on the OBA website.

- Charlotte gave a report of the 2019 Adult Tournament. There were no bids for the tournament so the OTBA Association will be running the tournament. The house has not yet been selected but there will be a tournament and it will be somewhere in Ontario

# **CTF Update from Brian McMaster**

He mentioned the CYC's and the Team Trials for next year and that he looks forward to working with all the local associations. He mentioned that there was a lot of positive change happening and looks forward to a lot of the changes. With that, he introduced Cathy Innis, CTF Executive Director.

# **CTF Update from Cathy Innis**

Cathy Innis spoke to the meeting and thanked Charlotte for the invitation. She said that there were a lot of changes coming, but there were a lot of things on the list that needed to be addressed. In order to get things done, she prioritized the items and some of them have not yet been addressed, but they are still on the list. She mentioned that the important thing to do is to not look back but to look forward and move towards change. Cathy mentioned that award inventory will now be based on usage, and the "subsequent" awards can now be administered immediately at the local level. They are also investigating options for getting the honour score awards (plaques and rings) delivered quicker. The new website is under construction and will be available in September. There is a lot of work being done in ORS to make it more efficient and to expand it and make the reporting better. The league kits will no longer send a USB stick and the letter enclosed will direct the league executive to the website where they can get all the up-to-date forms. All association Managers are urged to get correct email addresses for all of their participants. All bowlers will be able to print their sanction card from the ORS website once the local association manager has processed their payment.
