#### Presidents Report – Charlotte Konkle

First of all I would like to start out today by thanking you all for coming on a beautiful day in June when you probably would like to be out golfing or playing ball or something outside - the fact that you are here means that you care very much for our great sport of tenpin bowling.

- Kathy Rideout and Chris Woolcock with the Ontario Youth singles tournament and the Ivan Nelson tournament
- all of the committee chairpersons and the members of their committees
- Last but certainly not least the Board of Directors they are special people.

On that note I have to inform you that Maureen Close of Brockville 1000 Islands resigned from the board in November 2013 for health reasons. Ron Jones of Quinte has also resigned effective today. The Board of Directors will be appointing directors from these associations as soon as possible.

The OTBA Hall of Fame has some very special members - these people are the back bone of our present association and without them all we would not be where we are today. They are all listed on the large display case at the back of the room.

On this last weekend of May 31 - June 1, 2014, the CTF Youth Championships were held in Sault Ste. Marie Ontario - the results are on the CTF website and both the Southern Ontario and Northern Ontario teams did well. These bowlers are the future of our sport so we need to support them.

You all know that the Pan Am games are coming to Toronto in 2015 - the bowling venue is Planet Bowl in Toronto where the bowling will be held in July. Erin and Brian McMaster are the co-chairs of the Sport Organizing Committee. Since the Pan Am games test event was held during the CTF Canadian Team Trials on the long weekend, I have enclosed a report from Erin McMaster which outlines a lot of things that happened during this weekend. #### Presidents Report - Con't - Charlotte Konkle

In regards to the matter of amalgamation of the 3 bowling associations (Ontario 5 pin, Bowl Ontario and OTBA) there has been no further movement in having an umbrella organization of the 3 to deal with Sport Ontario funding. I have to add that I have been invited to attend Bowl Ontario's AGM for the past 2 years but both times I have been unable to attend. But this is a step in the right direction.

I am reminding all associations that OTBA offers awards to its members - the recipients names are sent in by the league secretary to the association manager who then forwards them on to the OTBA association manager. As most of you know we have had a problem with the new calculators and we hope to resolve this very soon.

OTBA will pay 25% up to a maximum of \$25 for any person who wants to take the coaching or lane inspector course offered by CTF. John McLean is the provincial coaching coordinator and Ron Jones is the person to contact for lane inspection courses

I had the privilege to representing Ontario at the CTF AGM in Montreal this past April and you have my full report later on in this meeting. I came away from that meeting with more hope for the future. At the moment, Deborah Hope of Greater Toronto, Dan Rose of WECKBA and Brian McMaster of Niagara are the 3 Ontario directors with Jim Lester of Lambton County as a director-at-large. Jim has a presentation from that meeting that he will be showing you after my CTF report.

It has been my very great privilege to have been involved in OTBA as a director for 4 years and as president for 6 - we have grown so much but we still have a way to go.

A motion by Ron Jones and seconded by Tim LaLonde was made to accept the presidents report. All in favour, carried.

#### **Association Manager – Douglas Imms**

- The Association Manager went over the reports. See the AGM minutes for the full report.
- The date for the fall meeting will be Oct 4 at 2pm 2014. The location will be the Hilton Garden Inn.

- Ron Jones made a motion, seconded by Tim LaLonde that the Association Managers reports be accepted. All in favour, carried.
- The association manager stated that next year we will be spending more money than we take in.
  - John McLean made a motion to increase the dues by \$1.00. This was seconded by Jim Lester.

    - Opposed 7
    - Motion failed.
  - Karen Nicol made a motion that any deficit for the association account be taken from the adult tournament account. This was seconded by Wayne Dubs. All in favour, carried.
- Ron Jones made a motion, seconded by Tim LaLonde that the financial statement be accepted. All in favour, carried.

#### **Committee Reports**

#### Youth Committee Meeting - John McLean

- John McLean stated that during the youth committee meeting this morning some changes were made to the youth tournaments.
  - John McLean stated that there will be an early bird fee for the Ivan Nelson CTF Tournament.
  - John McLean stated that we will be increasing the scholarship payout for the youth tournaments. This money will come from the scholarship account surplus (interest, unclaimed money etc.).
    - The Ivan Nelson CTF tournament will be increased to \$2,800.00
    - The Joyce Woolgar Family Twosome tournament will be increased by \$2,000.00
    - The Ontario Provincial Singles Tournament will be increased by \$2,0000.00
    - The Annual Provincial Tournament will be increased by \$4,000.00
    - The High Average awards will be increased by \$2,000.00
- Ron Jones made a motion, seconded by Jim Lester that we accept the Youth Committee Meeting report. All in favour, carried.

#### Hall of Fame - Ron Jones

- The Hall of Fame committee received NO submission this year

#### Audit - Denis Welch

#### Awards - Karen Nicol

At this time we have not added any additional awards. During the 2011 & 2012 season we had to find a new supplier for our Century Series awards which are calculator clocks. The supplier we found said they were able to find a similar product to the original ones we had purchased. We got these last season at the time of our AGM. We sent them out after our Board meeting in October of 2013. After these were sent out we started to get reports form the associations that many of them did not work.

I have talked to our supplier numerous times since the first reports of problems and he said they would contact his supplier. We did not get any feedback from them for many months.

I contacted them again this week and said we need a resolution of the problem. They have agreed to replace the batteries and we will take the ones to be issued for this season to them to replace.

#### Men's' and Women's' Tournament 2013 - Karen Nicol.

The 2013 Adult Provincial Tournament was held at Burlington Bowl on May 11,12,18,19, 25 and 26. We had some issues but in general it was a successful tournament.

The total number of teams was 206, Doubles was 358, Singles was 716 and All Events was 565.

In the <u>Men's Division</u> we had 94 teams and the winning team was RAM ROD from Hamilton & District TBP with a score of 3039. For the doubles we had 178 entries and the winners were Peter Samborsky and John price from Hamilton & District TBA with a score of 1686. The Singles event we had 407 entries and was won by Wayne Folk from London & district with a score of 888. The All Events winner was Jim Barber from Lambton County with a total of 2420. The optional <u>Scratch Events for Men</u> had 13 Teams, 33 Doubles, 81 Singles and 53 All Events. The Men's Scratch Team the winners were AQWA's Pro Shop from WECKBA with a total of 2686, Men's Scratch Doubles was won by Jason Lapoint and Jim Creasor from Lambton County with a score of 1383. The Men's scratch singles was won by Joe Ciach from Greater Toronto with a score of 788. Men's All Event Scratch was won by Joe Ciach with a score of 2130.

For the <u>Women's Division</u> we had 67 teams and the winning team was Something Old & Wild from Greater Toronto with a score of 3150. We had 129 doubles entries for the women and this winners were Sheila Carter and Shelly Watts from London & District with a score of 1565. In the women's single we had 309 entries and the winner was Debby Ayres from Greater Toronto with a score of 850. We had 260 All Events and the winner was Jocelyn Van Ekeren from Lambton County with a total of 2446. <u>For the Women Scratch we had 3 Teams, 8 Doubles, 22 Singles and 10 All Events.</u> The Women's Scratch Team winners were Foxes of the North from Greater Toronto with a score of 2402. The Women's Scratch Doubles winners were Wendy Agua and Haley

Hennon from WECKBA with a score of 1193. The Women's Scratch Singles winner was Cathy Harvey from Greater Toronto with a score of 702. The Women's Scratch All Events winner was Cathy Harvey from Greater Toronto with a total of 1987.

In the Mixed division we had 45 teams and the winners were Ottawa 14 from Capital District with a score of 3104. We had 51 doubles entries and the winners were Michelle Kelly and Phil Brownlee from Greater Toronto with a score of 1582.

For the <u>Mixed Scratch</u> we had 3 teams and the winners were Fire Breathing Rubber from Greater Toronto with a score of 2418. We had 4 Mixed Scratch Doubles entries and the winners were Bonnie Parker and Lou Strum from Greater Toronto with a score of 1139.

#### Men's' and Women's' Tournament 2014 - Charlotte Konkle

- Charlotte mentioned that the Un-official results are on the net, however the scratch does not have the last weekend of the tournament. Therefore these results will change.
- Charlotte also mentioned that next year's tournament will be held in Windsor.
- Tim LaLonde made a motion, seconded by Jayne Picott to accept the report. All in favour, carried.

#### **CTF Report – Charlotte Konkle**

- Charlotte went over her report. The full report is attached to the AGM package.
- A motion by Ron Jones, seconded by Karen Nicol was made to accept Charlottes report.

#### **CTF National Presentation – Jim Lester**

- Jim Lester went over the National Structure (see attachments). CTF National is now structured like a business. Managers can be fired and replaced.
- Jim Lester also mentioned that up to \$1.00 per bowler (next year) from National dues will be used to promote bowling programs for Junior Bowling. They are looking for ideas on how to spend this money and it must be approved 100% by the board.
- Jim also stated that CTF National is fighting hard to get bowling in the Olympics.
- Jim also stated that CTF National is also fighting hard to get the High Performance Funding back.

#### **Old Business**

#### **New Business**

- Charlotte Konkle stated that Maureen Close has resigned. Unfortunately there is no one stepping forward to represent Brockville.
- Charlotte Konkle stated that Ron Jones also has resigned. He is still a life member and Karen Gallant will be taking over his remaining 2 year term. Charlotte is asking the board to allow her to appoint Karen
  - o Motion by Tim LaLonde, seconded by Ron Jones. All in favour, carried.
- Charlotte received an invitation from Bowl Ontario to attend their AGM. Unfortunately she was unavailable to go due to the provincial tournament
- Jim Lester stated that Bowl Ontario 5 pin and 10 pin are now separate entities.
- Douglas Imms read a bid that was received to host the Annual Junior Provincial Tournament in 2017. This bid was received from London & District T.B.A.
  - Ron Jones made a motion that we accept this bid, seconded by Della Trude.
     All in favour, carried.
- Ron Jones went over the new ruling on Bowling Balls. See the whole question and answers below.
  - USBC now states that the maximum number of holes in a bowling ball is 5.
     You must use at least the thumb hole. If you do not use the thumb hole then it is considered a balance hole. If you already have a balance hole this one must be plugged. This ruling comes into place on August 1 and will be in the CTF rule book for 2014 2015.
- A motion was made by Ron Jones, seconded by Donna Lloyd that the meeting be adjourned. All in favour. Meeting adjourned 5:29.

#### FREQUENTLY ASKED QUESTIONS (related by USBC re thumb hole use)

## Q: Does this mean every bowling ball thrown by a no-thumb or two-handed bowler who uses no thumb is now going to be illegal and have to be re-drilled?

A: No. If a bowler doesn't use their thumb hole during delivery, they can either have a thumb hole or a balance hole but not both. If the ball has a thumb hole but the bowler doesn't use it, then as long as it meets static balance requirements, the ball is allowed. If the ball has both a thumb hole and a balance hole, the bowler needs to plug at least one of them. Please note that balance holes can't have removable devices or slugs installed in them.

#### Q: What about bowlers who sometimes use their thumb and sometimes do not use their thumb? For example, what if a bowler does not use their thumb for a strike

#### ball but does use their thumb for a spare shot?

A: The bowler would need to make sure the ball is within specification from both centers of grip (middle of the grip for the thumb in, and center of the bridge (the center point between the two finger holes) for thumb out. It is from this point that the ball would have to be within all static balance specifications – no more than 3 oz. top/bottom weight, no more than 1 oz. finger/thumb weight and no more than 1 oz left/right side weight.

If the bowler is going to switch back and forth between using their thumb and not using their thumb, they would need to use a ball without an additional balance hole. The specification will go into effect August 1, 2014.

#### Q: How is this rule enforceable and what is the penalty for those who don't comply?

A: Once it is discovered that a bowler is using equipment which is not within specifications, the ball must be removed from competition and corrected before it can be used during certified competition. If the bowler uses a ball that is non-conforming with knowledge that it's out of specification, then the scores are subject to forfeiture.

#### Q: Who is impacted by this rule?

A: This is strictly for bowlers who do not use their thumb regardless if they use a one-handed or two-handed approach.

### Q: If the bowler covers the thumb hole with their palm, would that count as gripping?

A: No, the bowler is not gripping the ball if they are just covering the hole with their palm.

#### Q: Why was the rule changed?

A: This rule change aims to create greater fairness by removing the potential advantage of two balance holes. If the bowler doesn't use the thumb hole for gripping, it's not really a gripping hole. A bowler who uses their thumb for gripping is allowed one balance hole.

#### Q: Did some people have an unfair advantage under the previous rule?

A: A bowler who doesn't use their thumb had the opportunity to move their thumb hole and balance hole to create additional drilling options that were not available to those who put their thumb in the ball.

#### Q: Is this only for thumb holes?

A: Yes. A bowler may remove a finger during any delivery and it would not be considered a violation of this specification.

#### Q: What about Individuals that use their thumb holes for spares only?

A; Individuals who use their thumb holes for spares would have two (2) options: Option #1: the ball being used for their first shot could not have both a thumb hole and a balance hole. The ball would have to be within static balance spees from the center of the bridge based on their first shot delivery as well as from the traditional center of the grip (the front edge of each finger hole to the front edge of the thumb hole) based on their second shot delivery using the thumb.

Note - in this case the thumb hole could not contain a removable device or slug.

Option #2: The bowler would have a separate spare ball in which they use their thumb that must be within balance from the traditional center of the grip.
