Charlotte welcomed everyone to the first board meeting of the season. Anne-Marie did the roll call

Anne-Marie presented the minutes of the OTBA Board of Directors Meeting of June 23th, 2018. M/S/C Wayne Dubs, Jamie Morand to dispense with the reading of the minutes. M/S/C Della Trude, Gary Rochon that they be approved. No discussion.

Charlotte presented her verbal President's Report Highlights of President's report:

Association Manager Report:

Anne-Marie went over her report. She went over the financial report as of July 31, 2018. The ending balance as of that date is \$10,663.95.

She showed the Provincial High Average Winners list and said that the plaques were given to the board members to deliver and present to the winners. Committee Reports:

Scholarship

Charlotte presented the scholarship committee report on behalf of John McLean. The surplus is \$63,622.99. This has not decreased much since the spring due to cashing in a GIC that had interest of over \$10,000. Tournaments

2018 Adult Tournament

Wayne reported that there is a financial statement prepared. He reported that a check for \$6,707.82 was given to the OTBA today and they are owed \$6,630.87.

2020 Adult Tournament

Charlotte presented a bid from Windsor-Essex-Chatham-Kent for the 2020 Adult Tournament. Proposed lineage is \$3.39 per game, taxes included. The tournament would be held at Rev's Rose Bowl. M/S/C Gary Rochon, Paul Minor to accept the bid. No discussion

Youth Tournament

Jayne said that all the Youth Tournament entries are posted on the website and the sanctions have been applied for. She already has entries into the Ivan Nelson. Jayne mentioned that there had been discussion about the second day of the Ivan Nelson Tournament. The tournament ran at a deficit last year and they were increasing the entry fee. Since scholarship money cannot be used for travel, fundraising will be essential for the bowlers attending the CYC's. There will also be a Team Manager this year so there will be those expenses needing to be covered as well.

Seniors

Charlotte presented the results from the Senior Championships in Las Vegas for the 2018 tournament. Six Ontario bowlers attended the tournament. Next year the tournament is in Cincinnati, Ohio and in 2020, the tournament will be held in Louisville, Kentucky.

Old Business

Respect In Sport

Charlotte mentioned that at the last meeting there was a list of certified coaches given out to the attendees. The question now is who will police this list. Blaine Boyle will be updating and policing the list and keeping it up to date on the CTF website. CTF is currently looking into getting more people certified and there will be more information available soon. Part of the process for certifying coaches is taking the 'Respect In Sport' course. This needs to be done and the provincial associations will be making sure that this course has been taken. As a provincial board, we will need a Coaching Co-ordinator that will be in charge of making sure the coaches have all taken this course. Charlotte asked if anyone was interested in this position and to let her know.

2019 Adult Tournament

Charlotte brought up the 2019 Adult Tournament that will be held at Leisure Lanes in Oshawa. The 10-pin rule is in effect and we will also be allowing e-transfers this year. Charlotte asked for the times that each board member is available to work and for them to let her know as soon as they can. OTBA will cover the cost of rooms if the board member comes to help. The entry forms are ready but are not to be distributed until the Senior Tournament weekend. Charlotte asked for someone to take the lead in arranging a gift for the team bowlers at the tournament. Karen agreed to take this on.

New Business

Policy Manual Change

There needs to be a policy change for sport/challenge averages under the awards section. A sport/challenge average will be converted to a standard average for adult and youth average awards. M/S/C Della Trude, Wayne Dubs to accept the change. No discussion.
